The meeting was called to order by Supervisor Criss at 7:05PM.

The meeting began with the Pledge of Allegiance.

Supervisor Criss introduced Russ Heslin. Russ indicated that he phoned Mr. Criss regarding assessment errors he was finding in the Amity Tax roll. Mr. Criss asked Rus to bring a few examples for the board to look at. A package was provided for all board members. Russ explained the data shown in this package which contained documentation of assessment errors that he has uncovered in the Town of Amity. He went over the documents in the package with the board. He explained that some assessments were more than they should be while others were less. Errors in all aspects of the assessments were found. These include invalid land usage, exemptions etc. He indicated that errors in assessed value could only be changed by doing a new re-assessment. He will fix errors as they come to his attention. He also went over the requirements for the aged exemption and explained that the use of the Income Verification form is not good for many taxpayers. The State does not verify a person for aged exemption but that his office does.

The reading of the November minutes was waived. All board members had copies of the minutes which they had previously read. Supervisor Criss indicated that the word not was left out of the statement he made regarding the fact a resolution could not be used to change a law. The word not will be included. Councilman Skinner indicated that the word not was also missing from the statement regarding piggybacking on existing contracts. The word not will be added. No other corrections were noted. The Clerk will make the corrections before certification and publishing of the minutes.

Councilman Skinner made a motion to approve the minutes with noted corrections. Councilman Presutti made the second. Councilmen Skinner, Presutti, Zenoski and Supervisor Criss all voted Aye. There were no Nay votes. Motion carried 4-0-0.

The reading of the budget workshops held was waved. All board members had copies which they previously had read. Supervisor Criss made a motion to accept the minutes of both workshops. Councilman Skinner made the second. Councilmen Skinner, Presutti, Zenoski and Supervisor Criss all voted Aye. There were no Nay votes. Motion carried 4-0-0.

The reading of the public hearing minutes was waved. All board members had copies which they previously had read. Supervisor Criss made a motion to accept the minutes of both workshops. Councilman Skinner made the second. Councilmen Skinner, Presutti, Zenoski and Supervisor Criss all voted Aye. There were no Nay votes. Motion carried 4-0-0.

Clerk Winterhalter told the board that in the minutes he wrote that Supervisor Criss had called Russ Heslin two weeks prior to the meeting and told him he was hired. In actuality Supervisor Criss had taken a straw vote among the Councilmen and determined that there were sufficient votes to appoint Russ as the assessor. Clerk Winterhalter correct this error after the board approved the minutes. Clerk

Winterhalter then asked for a motion and a vote to allow this correction to the September minutes.

Councilman Skinner made the motion to allow the correction. Councilman Presutti made the second. Supervisor Criss, Councilmen, Skinner, Presutti, aafnd Zenoski all voted Aye. There were no Nay votes. Motion carried 4-0-0.

The board received a late application for the Highway Superintend opening due to the retirement of Jim Reniff. To be fair the board accepted this application. A motion to enter executive session to interview Doug Serra was made by Supervisor Criss. The Second by Councilman Skinner. Supervisor Criss, councilmen Skinner, Presutti and Zenoski voted Aye. Motion carried 4-0-0. Executive session entered at 7:49 PM.

Executive session ended at 8:15 PM and the regular meeting resumed.

Supervisor Criss introduced Resolution 2013-018 to restrict the hours of WilMac Park. Supervisor Criss read the resolution then made a motion to accept the resolution. Councilman Skinner made the second. Supervisor Criss, Councilmen Skinner, Presutti and Zenoski all voted Aye. The motion carried 3-0-0.

EXCEEDING \$85,000.00 (Eighty five thousand and no cents) OF SAID TOWN TO FINANCE THE COST OF A 2015 MAC PLOW TRUCK.

BE IT RESOLVED, by the Town Board of the Town of Amity, Allegany County, New York, as follows:

Section 1. In anticipation of the issuance of sale of said bonds of the Town of Amity, the power to authorize of and to sell bond anticipation notes of the Town of Amity, Allegany County, New York, in aggregate sum not exceeding \$85,000.00 (Eighty five thousand and no cents), is hereby delegated to the Town Clerk, the chief fiscal officer. Such notes shall be sold in such manner as may be prescribed by said Town Supervisor of the Town of Amity in accordance with the Local Finance Law.

Section 2. The notes hereby authorized, or any portion thereof, shall not be issued until such Town Clerk shall have first filed with the Town Board of said Town, a certificate providing for the details of such notes, which certificate shall contain the statements required by Section 30.00 of the Local Finance Law.

Section 3. The bond anticipation note totaling \$85,000.00 (Eighty five thousand and no cents) is not a renewal. There are currently no other outstanding bond anticipation notes for the Town of Amity.

Section 4. This \$85,000.00 (Eighty five thousand and no cents) bond anticipation note hereby authorized shall mature on July, 31 2019.

Section 5. This resolution shall take effect immediately.
